In order for its websites to function properly, RNE sometimes places small data files called cookies on your device. Most major websites do this as well. RNE hereby informs you of the use of cookies on your device through this cookie policy.

1. What are cookies and what are they used for?

In short, cookies are a tracking technology, and you have the right to refuse to be tracked. A cookie is a small text file that a website stores on your device (e.g. computer/smartphone/tablet) when you visit it. It allows the website to remember your actions and preferences (e.g. login, language, font size and other display preferences) over a period of time so that you do not have to re-enter them each time you return to the website or move from one page to another.

They are used to ensure the quality, usability and correct functioning of the websites, to store and retrieve information about browsing habits and to personalise content and can sometimes be used to recognise the user of a website.

2. What type of cookies exist?

Cookies can be divided into different types according to different criteria. The same cookie can belong to different categories.

2.1. According to the entity that manages them:

- a) own cookies: those that are sent to your computer or device by the website managed by RNE itself and from which the service requested by you is provided;
- b) third-party cookies: those sent to your device from a computer or domain that may or may not be managed by RNE but by another entity that processes the data gathered by the cookie for its own purposes.

RNE's own cookies are identified in this policy as being owned by RNE. The rest are owned by the third parties indicated. By clicking on the name of the third party, you can access their respective cookie policies, including transfers to third countries where applicable.

2.2. Depending on the length of time they remain activated on your device:

a) Session cookies are designed to collect and store data during your visit to the website. The information is stored only during the session and disappears when the session ends.



b) Persistent cookies store user information for a longer period of time that can be accessed and processed by the party responsible for each cookie during that period. This period varies from cookie to cookie and can range from a few minutes to several years.

2.3 Depending on their purpose:

- a) technical cookies (necessary cookies): these cookies allow the website to function correctly and are therefore essential for browsing the website and using all its options and functions correctly;
- b) preference or personalisation cookies: these are cookies that allow information to be stored so that you can access the website with characteristics that may differentiate your experience from that of other users, such as the appearance or content of the website, which may vary depending on the type of browser you use;
- c) analysis or measurement cookies: these are cookies that make it possible to quantify the number of users and their connection time in order to measure and statistically analyse their use of the services offered.
- d) advertising cookies: these are cookies that allow the most effective management of the advertising spaces that may be included on the website;
- e) behavioural advertising cookies: these allow the effective management of the advertising spaces that may be included on the website, by storing information on your behaviour obtained thanks to the continuous observation of your browsing habits, which allows the development of a specific profile to display advertising based on the same.

4. Are international data transfers made when using cookies?

The acceptance of some cookies may involve the international transfer of data to third countries, which is necessary for the functioning of our providers' services. The legal basis for such transfers is your consent, as expressed when you accept the use of such cookies. In any case, international data transfers will be carried out with an adequate level of protection based on the provision of adequate safeguards such as standard contractual clauses (Articles 45 and 46 of the GDPR).

5. How to manage cookies in general?

You can allow, block or delete cookies installed on your desktop or laptop computer at any time using the customisation options of the browser you are using (e.g. Google Chrome, iOS Safari, Mozilla Firefox, Microsoft Edge). Please note that if you disable all cookies, some features or content of the website may be affected, and the quality of your web experience may be reduced.

The settings for disabling cookies can be found in 'Options' or 'Preferences' menu of your browser. For full instructions, please search online in your browser.

Cookies and other tracking technologies are also used when you access the website from mobile devices (e.g. mobile phone, tablet). As with computer browsers, mobile device browsers allow you to change privacy options or settings to disable or delete cookies.

To change your privacy options, follow the instructions provided by the developer of your mobile device browser.

6. How to manage cookies on this website?

Our cookie tool, called Cookiebot, allows you to manage the installation of cookies, refuse their use or revoke your consent at any time and as often as you wish.

When the box is unchecked, you are disabling cookies on your device. This means that your visits to this website will not be recorded by the Cookiebot tool.

If the box is ticked, you are opting in to cookies on your device. This means that you agree to the installation of cookies on your device and the analysis performed by the Cookiebot tool.

You can change your consent to cookie tracking here:

Please note that if you reject all cookies, it is possible that some basic functions of the website may be affected. In addition, if you clear your cookies, delete the opt-out cookie, or if you change computers or web browsers, you will need to perform the opt-out procedure again.
